TESTIMONY IN OPPOSITION TO THE THIRTY METER TELESCOPE — RELOCATION TO A "DISTURBED" SITE

Aloha. My name is Amber Kuileimailani Bonnici, and I am submitting testimony in firm opposition to the continued development of the Thirty Meter Telescope on Hawai'i Island, including the proposed "relocation" to what has been labeled a "disturbed site."

I want to be very clear:

Calling any part of Mauna Kea "disturbed" does not give permission to cause more harm.

It is not a blank check to continue ignoring the voices of Kānaka Maoli and the wider community who have already said no—for years.

For over a decade, people from this land—local families, cultural practitioners, protectors, students, kūpuna—have stood in peaceful protest. They have been arrested. Criminalized. Spoken over. And yet they continue to show up because Mauna Kea is not simply a location for a project. It is a sacred mountain. It holds ecological, cultural, spiritual, and ancestral significance that cannot be measured in financial value or scientific prestige.

We have said no.

We are still saying no.

And the reason we have to keep saying no is because those in power have not been listening.

The existing telescopes on Mauna Kea were built under promises that have not been kept.

• They have not been properly decommissioned.

- There has been pollution.
- There has been environmental harm.
- There has been mismanagement and a failure of stewardship.

The land has already carried more than its share of burden.

To now propose placing the TMT on a "disturbed site" continues a harmful pattern:

- 1. Disturb,
- 2. Call it justification for further disturbtion,
- 3. Ignore the will of the people in the process.

This is not pono.

The truth is, the driving force behind the TMT is not the will of the people of Hawai'i.

It is money, institutional power, and external interests.

If community voice and environmental responsibility were truly at the center, we would see decommissioning completed first, pollution cleaned up, and a pause long enough to actually listen—not just hold scripted discussions.

Science is not the enemy. But science without consent, without accountability, without respect for 'āina, and without regard for Indigenous sovereignty is not progress. It is another version of colonization dressed as innovation.

I urge you to stop this project, in any location on the mauna.

Honor the years of community testimony.

Honor the arrests and sacrifices of local families.

Honor the cultural and environmental significance of Mauna Kea.

Honor the repeated "no" that has been spoken loud and clear.

Hawai'i deserves better than decisions made for profit under the language of "disturbed."

Our 'āina deserves better.

Our people deserve better.

My name is Lauren Taijeron. My connection to Maunakea is as a non-Hawaiian resident of these islands who stands with the Hawaiian people and their calls for the protection of their lands.

The October 24th letter from Governor Green and the Hawaiii Congressional delegation is highly disappointing and disturbing. The letter, addressed to the TMT International Observatory, not to the people they are elected to represent, states that they will work with the MKSOA and UH to "promptly establish a clear and transparent procedure to obtain the necessary permits associated with a decommissioned site".

While the proposed construction site may have changed, no other conditions have. The summit remains a conservation district, and the source waters of all life that depends on it from below. The refrain of thousands across the pae 'āina remains Kū Ki'a i Mauna.

During previous contested case hearings, UH/ TMT previously stated the TMT could not be put on decommissioned sites because it is too big for the summit. If TMT is going to be redesigned to make it small enough to move - then all the permits need to be redone - conservation district, sublease, EIS, management plan, etc. - and all of the public processes associated with them.

The letter is in disturbing alignment with so much we are seeing across U.S.-occupied territories, where politicians and corporations talk behind closed doors, bump fists, and attempt to roll over the will and peace of the community.

I urge the Maunakea Stewardship and Oversight Authority to resist this excessive overreach by the Governor and congressional delegates to consolidate power and clear a path for the Thirty Meter Telescope on Maunakea.

I remind the Authority that the summit of Maunakea is not just sacred; these are Hawaiian national lands that the Hawaiian Kingdom government or people never relinquished. I personally commit to standing again, if necessary, and for as long as it takes, to protect our mountain, our water, and the dignity of our people.

I will no longer accept the erratic piecemeal of recognition politics, where our claims of identity need to be negotiated through the whims of election cycles. I do not accept the *possibility* of justice in the context of your ongoing and continuous dispossession of my people, my ancestral home, and my birthright that is the stewardship not only of Mauna Kea but the entirety of our pae 'āina.

I refuse your appearance of governmental action that frames kanaka 'ōiwi as the "problem" without disrupting the actual power of the ongoing colonial "state". There will be no land-swaps, no deals, no acceptance of "what we can get". I will surrender no lands. Lāhui will surrender nothing.

The irony is that you, your children and generations to come will be the beneficiary of our refusal here and everywhere on pae 'āina.

During previous contested case hearings, UH/TMT had previously stated that the TMT could not be placed on decommissioned sites because it is too large for the summit. If TMT is going to be redesigned to make it small enough to move - then all the permits need to be redone - conservation district, sublease, EIS, management plan, etc. - and all of the public processes associated with them.

The letter is in disturbing alignment with so much we are seeing across U.S.-occupied territories, where politicians and corporations talk behind closed doors, bump fists, and attempt to roll over the will and peace of the community.

I urge the Maunakea Stewardship and Oversight Authority to resist this excessive overreach by the Governor and congressional delegates to consolidate power and clear a path for the Thirty Meter Telescope on Maunakea.

I remind the Authority that the summit of Maunakea is not just sacred; these are Hawaiian national lands that the Hawaiian Kingdom government or people never relinquished. I personally commit to standing again, if necessary, and for as long as it takes, to protect our mountain, our water, and the dignity of our people.

My name is Erin Lau, and I am Kanaka Maoli from Oʻahu, with deep family connections to not only my moku, but also to Maui and Hawaiʻi Island. I was on Mauna Kea during the frontline actions in 2015 and 2019, working with the media hui to film and document the many ways our community came together in unity and resistance.

My time on the mauna deeply affected me. It was the first time I truly understood what it means to be Hawaiian. In the simplest words, it is about aloha 'āina, knowing that our kuleana is to love and protect the land as we love our families and each other. That love means protecting Mauna Kea from harm.

Mauna Kea is our kūpuna, and there is no acceptable location upon her that would be appropriate **for** construction. I strongly urge that no construction take place anywhere on our sacred mauna, and I request the MKSOA to resist excessive overreach by the Governor. Please uphold a process grounded in transparency and accountability in alignment with all applicable laws, to ensure that the integrity of Mauna Kea is truly protected.

After the 2019 stand, I helped produce a documentary titled STANDING ABOVE THE CLOUDS, a feature film that highlights the movement to protect Mauna Kea through the intergenerational stories of women in three Native Hawaiian families. Since completing the film last year, our team has hosted over 80 screenings across several countries, reaching more than 5,000 students. Time and again, I've witnessed how the fight to protect Mauna Kea resonates with people around the world. I am also often reminded that there are many similar frontlines happening globally, fighting to protect sacred places, clean water, and the right to self-determination. For me, this continues to be part of that larger movement.

My name is Noelani Akiona. I am a Kanaka Maoli whose moʻokūʻauhau is grounded in Moku o Keawe and Waimea; Mauna a Wākea is my kupuna, relative, and piko.

I'd like to start by naming and honoring the thousands of people who have stood to protect Maunakea from becoming a place for industrial development for decades; and to remember the 2015 standoff on Maunakea that led to the arrest of nearly a dozen kia'i out of the hundreds who stood across the road, arms locked to prevent that day's attempted construction.

This prepared the lāhui for the historic 2019 standoff off where 30 kupuna were arrested to protect the Mauna from new construction, along with the tens of thousands who supported them in holding down an eight-month occupation that to this day has prevented the desecration of our Mauna. And that stand-off prepared it for the next attempt to construct, if there is any, to come.

The October 24th letter from Governor Green and the Hawai'i Congressional delegation is highly disappointing and disturbing. The letter, addressed to the TMT International Observatory, not to the people they are elected to represent, states that they will work with the MKSOA and UH to "promptly establish a clear and transparent procedure to obtain the necessary permits associated with a decommissioned site".

While the proposed construction site may have changed, no other conditions have. The summit remains a conservation district, and the source waters of all life that depend on it from below. The refrain of thousands across the pae 'āina remains Kū Kia'i Mauna.
