Permit the Department of Land and Natural Resources, Division of State Parks, to Establish an Annual Fee for the Registration and Numbering of Rental Vessels at State Parks by Special Use Permit Statewide.

### LEGAL REFERENCE:

Act 128, House Bill 1316 (2025), Hawaii Revised Statutes (HRS) § 184-3, 3.2, and Hawaii Administrative Rules (HAR) §§ 13-146-5(1), -54.

### BACKGROUND:

The legislature passed Act 128, House Bill 1316, on May 5, 2025. (**Exhibit A**.) The Act prevents any person, beginning January 1, 2026, from renting or leasing, or offering to rent or lease, a vessel to transit navigable waters of state parks unless it "is registered and numbered" with the Department of Land and Natural Resources, Division of State Parks (DSP). *Id.* DSP has under its jurisdiction the following parks where individuals can launch a vessel to transit navigable waters: Ahupua'a 'O Kahana State Park, Kealakekua Bay State Historical Park, and Wailua River State Park

#### DISCUSSION:

Adhering to Act 128 requires DSP to establish a method for the registration and numbering of rental vessels by January 1, 2026. DSP is also therefore required to develop a decal whereby the registration number may be affixed to the rental vessel. A "vessel," as defined in Act 128,

includes but is not limited to barges, boats, canoes, catamarans, charter boats, cruisers, ferryboats, fishing boats, flatboats, floating cabanas, houseboats, jet skis, kayaks, motor vessels, motorboats, party boats, powerboats, rafts, rowboats, sailboats, scows, ships, stand-up paddleboards, towboats, tugs, windsurfers, or any similar buoyant devices permitting or capable of free flotation.

The Act imposes two options for DSP to pursue in establishing the process for registration and numbering: (1) adopting a rule or (2) issuing special use permits (SUPs) under HAR 13-146-54. DSP is electing the latter option for expediency.

Under HRS § 184-3(6), DSP may "charge and collect reasonable fees" for the use of state-park resources, and under HRS § 184-3.2(a), the Board of Land and Natural Resources (Board) may adopt administrative fee schedules for "special use activities." Accordingly, as provided under DSP rules, the Board establishes the fee for the use and payment of SUPs. See HAR §§ 13-146-5, 13-146-54. This is a less complex and time-consuming process than adopting new rules to accommodate Act 128, which would not be adopted before January 1, 2026. DSP will then develop an Act 128 decal and administer special use permits by January 1, 2026.

Our sister division, the Division of Boating and Ocean Recreation, charges \$75.00 for annual boat ramp decals under HAR § 13-234-34(a). DSP finds this pricing to be reasonable and applicable for the registration and numbering of vessels under Act 128. Therefore, DSP proposes that the Board establishes an annual fee of \$75.00 for the registration and numbering of any vessel rented or leased by a permittee, the fees to be deposited into the state parks special fund.

In addition to any other conditions imposed by the Board, DSP intends to include in the SUP the following conditions of use for rental vessels transiting navigable waters of a state park:

### The Permittee shall:

- Comply with all federal and state laws and the rules of the Department of Land and Natural Resources ("DLNR").
- 2. Fully assume all risk incidents in renting a vessel to the public.
- Report all accidents, injuries and incidents to the DLNR, Division of Conservation and Resources Enforcement (DOCARE) at (808) 643-3567 immediately and the State Park's office at (808) 587-0300 as soon as possible.
- 4. Complete and submit monthly to DLNR, with the fee payment, the attached Statement of Gross Receipts. The completed statement shall include the number of patrons and gross revenues per day for park data collection purposes.
- 5. Limit the days for public use of rental vessels to Monday through Friday, from sunrise to sunset, and, if applicable, adhere to time slots assigned by DSP.

- 6. Require patrons to disclose which state park they will operate the rental vessel in. The permittee shall inform the patron of the rules of that state park before renting the vessel.
- 7. Inform patrons to keep a safe distance between other vessels and to heed all warning and safety signs and refrain from using the rented vessel in dangerous weather conditions (e.g., heavy rain, flash flooding, and lightning).
- 8. Not rent vessels if a flood advisory, flash flood watch or flash flood warning issued by the National Weather Service is in effect for the park where the vessel will be used.

### The Permittee acknowledges that:

- 9. The Permit shall not be transferable, so that whenever a Permittee parts with possession or transfers the title to or any interest in this business named on this permit to another person by any arrangement, this Special Use Permit shall expire. The new possessor, transferee, or owner(s) shall have no right to use this permit.
- 10. The Permit may be terminated at any time without advance notice if Permittee violates or has previously violated permit conditions or provisions within a year of this Permit.
- 11. Permittee shall at all times use due care for public safety and defend, hold harmless and indemnify the State, its officers, agents and employees from and against all claims or demands for damages, including claims for property damage, personal injury, or death arising out of an incident to the operations permitted under this Permit.
- 12. DLNR reserves the right to alter or adjust the operation procedures within the permit expiration date for reasons deemed necessary, including temporary closures of parks for health and safety or search and rescue reasons.
- 13. Permittee understands that non-compliance with any of the terms and conditions of this Permit shall be cause for termination of this Permit. Upon notification by the DLNR, the Permittee shall be required to immediately cease and desist all rental operations.
- 14. This Permit or any rights hereunder shall not be sold, assigned, conveyed, leased, mortgaged or otherwise transferred or disposed of.

### RECOMMENDATION

The Division of State Parks is requesting that the Board of Land and Natural Resources:

- 1. Establish the fee for the registration and numbering of a rental vessel by special use permit at seventy-five dollars per annum (\$75.00.)
- 2. Authorize the Chairperson to prescribe other terms and conditions as may best serve the interests of the State.

### A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the people of Hawaii									
2	have significant concerns about the effects of over-tourism,									
3	including impacts to the environment, and particularly the									
4	proliferation of rental kayaks and stand-up paddleboards									
5	statewide. The legislature further finds that it is beneficial									
6	for the residents and natural resources of the State to regulate									
7	commercial rentals where a state park is the location of the									
8	watercraft activity. The legislature additionally finds that									
9	Wailua river state park on Kauai, Kealakekua bay state									
10	historical park on Hawaii island, and Ahupuaa O Kahana state									
11	park on Oahu are the only navigable waters within a state park.									
12	Therefore, the purpose of this Act is to require:									
13	(1) The registration and numbering of rental vessels									
14	before they are rented or leased, or offered for rent									
15	or lease, to the public for transiting the navigable									
16	waters of a state park; and

- 3 SECTION 2. Chapter 184, Hawaii Revised Statutes, is
- 4 amended by adding a new section to be appropriately designated

### Report Title:

Rental Vessels; Registration; Numbering; Navigable Waters; Wailua River State Park; Kealakekua Bay State Historical Park; Ahupuaa O Kahana State Park; State Parks Special Fund

### Description:

Beginning 1/1/2026, requires rental vessels to be registered and numbered with the Department of Land and Natural Resources before being rented or leased, or offered for rent or lease, by the public for transiting the navigable waters of a state park. Requires registration fees to be deposited into the State Parks Special Fund. Effective 7/1/2040. (SD1)
