# CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules ("HAR") §11-200.1-15 and -16 and the Exemption List for the Department of Land and Natural Resources reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to General Exemption Type 1 for "[o]perations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing." Specifically, the subject request is exempt under Part 1, Item 44, which applies to "[p]ermits, licenses, registrations, and rights-of entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." # APPLICANT REQUIREMENTS:

Applicant will be required to post a deposit of \$2,500 to ensure timely clean-up after the event described above. Payment shall be made in the form of a certified check payable to the Department of Land and Natural Resources. The deposit may be held by the Department for up to seven (7) days after the scheduled fireworks event and, if not forfeited under the conditions discussed below, will be returned to the Applicant.

# REMARKS:

The Applicant, Hawaii Explosives & Pyrotechnics, Inc. is requesting the issuance of a right- of-entry permit for the setup and firing of a fireworks display at Duke Kahanamoku Lagoon on January 18, 2026, for a private event being hosted at the adjacent Hilton Hawaiian Village. The Applicant submitted the request on October 31, 2025. The public will be able to view the private event show, provided they remain outside of the safety zone during the event.

The Applicant currently holds a right-of-entry permit approved by the Board to conduct weekly fireworks displays on Friday nights at an adjacent location on Duke Kahanamoku Beach and has previously been granted right-of-entry permits for up to four similar private firework displays launched from the Lagoon site per year over the past several years, including one such permit issued in 2025. The Applicant's current request is functionally identical to these prior Board-approved permits for displays launched from Duke Kahanamoku Lagoon.

The setup and firing of the aerial fireworks display for the event will include the work zone/ staging area consisting of 500 square feet and the safety exclusion zone consisting of 151,976 square feet. Preparation, firing of the aerial fireworks display, and clean up takes place from 12:00 p.m. to 11:45 p.m., at Duke Kahanamoku Lagoon (**Exhibit C**). According to the Applicant, the approximate firing window is between 6:30 p.m. to no later than 7:30 p.m., and the show will last for about four minutes. The safety exclusion zone will be closed from for approximately one hour and five minutes including the four-minute display period and the respective 30 minute periods immediately preceding and following the display.

The Applicant has provided the Department with a current certificate of liability insurance documenting the following current policies:

For these individual private events, staff is recommending that the Board adopt the same rental calculation method used for the weekly Friday night shows as previously approved by the Board at its meeting on April 26, 2024, under agenda item D-12 and amended on May 24, 2024, under agenda item D-6.

The rental amount is calculated as follows, to reflect the difference in time periods which the respective zones will be closed to the public:

Work zone/ staging area:	\$0.10/ foot <sup>2</sup> X 500 feet <sup>2</sup> =	\$50 +
Safety exclusion zone:	\$0.10/ foot <sup>2</sup> X 151,976 feet2 X 1/24	\$633

The Applicant will be required to comply with the standard terms and conditions for rights-of-entry for fireworks displays including, without limitation, submission to the Department of satisfactory evidence of post-event clean-up, consisting of: (i) date-stamped photographs of the premises taken during the daytime on the day of the event and on the day immediately following the event; (ii) a certification regarding the clean-up of the premises in the form used for these types of events completed by the Applicant; and (iii) a certification regarding the clean-up of the premises in the form used for these types of events completed by the property owner or operator who contracted for the event, or who accommodated guests who contracted for the event.

The Applicant has not had a lease, permit, easement, or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

The Office of Conservation and Coastal Lands (OCCL) was consulted on this submittal. OCCL has no objections to the issuance of this ROE permit because lateral beach access shall be maintained, this is a one-day event, and the area of the display appears to be contained and mauka of the shoreline. OCCL also concurs with the proposed Environmental Assessment exemption pursuant to Chapter 343, HRS.

There are no additional pertinent issues or concerns.

## **RECOMMENDATION**: That the Board:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Sections 11-200.1-15 and -16, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.

- 2. Authorize the issuance of a right-of-entry permit to Hawaii Explosives & Pyrotechnics, Inc. covering the subject area for aerial fireworks display purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - A. The standard terms and conditions of the most current right-ofentry permit form for aerial firework displays, as may be amended from time to time; and
  - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.



Exemption Type 1 for "[o]perations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing." Specifically, the subject request is exempt under Part 1, Item 44, which applies to "[p]ermits, licenses, registrations, and rights-of entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

Cumulative Impact of Planned Successive Actions in Same Place Significant? No. Similar events occur at the same location from time to time. However, based on the multiple environmental cleanups conducted after each display to remove debris from the lagoon area, staff believes that there would be no significant

cumulative impact.

Significant Impact on Particularly Sensitive Environment?

The requested area is a portion of State beach visited by tourists and residents and is heavily impacted by human activity. Public access across the requested area is maintained by the Hilton Hawaiian Village staff. In addition,

based on the analysis below, staff believes there would be

no significant impact to sensitive environmental or

ecological receptors.

Consulted Parties: The Office of Conservation and Coastal Lands (OCCL)

concurrs with the proposed exemption.

Analysis: The Board has permitted similar events in the past. The

proposed activity is of a similar type and scope of beach activities that have periodically occurred and continue to occur on this and other beach areas across the State.

Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. Staff also believes that the request would involve negligible or no expansion or change in use of the subject area beyond that

previously existing.

Recommendation: It is recommended that the Board find that this project

will probably have minimal or no significant effect on the environment and is presumed to be exempt from the

preparation of an environmental assessment.
