Please accept this testimony in support of Kaheawa Wind Power's Final Habitat Conservation Plan and the issuance of the associated Incidental Take License (Agenda Item C-3), as well as the approval of the proposed long-term lease (Agenda Item D-4).

Hawai'i continues to face some of the highest electricity costs in the nation, and maintaining reliable, existing renewable energy resources is an important part of reducing dependence on imported fossil fuels and limiting long-term environmental impacts. The continued operation of current renewable infrastructure helps support energy stability while broader sustainability goals are pursued statewide.

Kaheawa Wind Power has been in operation for approximately twenty years and remains an established source of renewable energy on Maui. As no changes are proposed to the existing turbine locations or project footprint, approval of the Final Habitat Conservation Plan and long-term lease would allow operations to continue without interruption.


